President's Report

The President announced that he will stand down at the end of this meeting. He reflected on the progress the sub-branch has made in the last ten years, especially with building improvements. He particularly thanked the secretary and treasurer for their work on behalf of the sub-branch. He said that a lot of visits to the aged care home and welfare visits didn't just happen - there was a lot of organising done behind the scenes, and were not really recognised by our members. Even during Covid, the work in this area was terrific.

Our fundraising achievements during the Anzac and Poppy Appeals continue to be fantastic. He acknowledged the Women's Auxiliary for their continuing help and also the"D Team" - Pam and Kev Davis, their children and grandchildren all helping to make the President's job easier. Lastly he thanked his wife Lynn for her untiring support.

Correspondence

The Secretary reported that 122 items of interest were received and dealt during 2023. All items are in hard copy and available for perusal.

From the previous AGM there was only one item to raise. The membership voted an annual \$200 honorarium for the main office bearers to recognise the hours spent for the club. He thanked the members, and for comparison noted the State Branch President receives an honorarium of \$10,000.

Treasurer's Report

The Treasurer's report is at Annex A to these minutes. It shows the Assets, Receipts and Expenditures for 2023.

George Browney said we had out-of-ordinary expenditures of about \$9,300 on the Honour Boards, \$4,000 on guttering and \$1640 on the new flagpole, meaning we made a loss of about \$7,000 for the year. Insurance has almost doubled - we use the RSL's broker Marsh for our insurance rather than

shopping around for a better deal (we would have to itemise everything in the building, and it's not worthwhile doing that).

Our term deposits are now attracting about 4% interest, and Term Deposit #1 of about \$64,400 is to mature in 17 days time. It will be rolled over.

The Poppy Appeal of November 2023 raised \$11,830 of which our club retained half that amount, as well as the \$1400 received in donations.

The Golf Day was down in numbers of entrants, but still raised \$3,400 for the club, thanks in the main to a donation from our major sponsor Mortimer's petroleum. Since 2014, our annual golf day has raised over \$35,000 - a tremendous effort.

Moved George Browney, seconded Des Connor, that the Treasurer's report be accepted.

Wellbeing Officer

Pam Davis said that she has been the Wellbeing Officer organising age care visits since 2010. Although she is happy to continue in the role of Wellbeing Officer, she would like the members to create a new post of Visits Officer to reduce her workload. She thanked those who have helped along the way, especially Carol Browney and Maurie Dean.

The work of the volunteers who make the Anzac and Poppy Appeals such a success every year were much appreciated.
